3 **WHEREAS, the Tuberculosis Program in the Executive Branch of the Tohono**  
4 **O'Odham Nation receives funding through a contract with the State**  
5 **of Arizona to pay for the program's operating expenses; and**

7 **WHEREAS, the Tuberculosis Program feels that this budget is not adequate to**  
8 **support the type and level of service needed by the people of the**  
9 **Tohono; and**

10 **WHEREAS, the Tuberculosis Program has submitted a supplementary budget**  
11 **(attached hereto and incorporated by reference) for approval by the**  
12 **Legislative Council of the Tohono O'Odham Nation with a request for**  
13 **an appropriation of funds; and**

15 **WHEREAS, the Health & Human Services Committee of the Legislative Council,**  
16 **with the oversight responsibility for the Tuberculosis Program, has**  
17 **reviewed this budget and appropriation request and recommended**  
18 **their approval and adoption; and**

20 **WHEREAS, the Budget and Finance Committee of the Legislative Council has**  
21 **reviewed this budget and appropriation request and recommended**  
22 **their approval and adoption.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono**  
24 **O'Odham Nation that it approves the FY-1992 supplementary budget**  
25 **submitted by the Tuberculosis Program.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 25th day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,444.0 FOR; -0- AGAINST; -0- NOT VOTING; and 280.0 [10] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




