11 **to the Hickiwan District based on residence population.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
13 **it hereby approves the Hickiwan District FY-92 Budget.**

18 **ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article**
19 **VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of**
22 **the Act of June 18, 1934 (48 Stat. 984).**
