12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that
13 it hereby approves the Sells District FY-92 Budget.

16 the 25th day of September, 1991 at a meeting at which a quorum was presented
17 with a vote of 1,444.0 FOR; -0- AGAINST; -0- NOT VOTING; and 280.0 [11]
18 ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article
19 VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
20 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
