WHEREAS, the Schuk Toak District Council convened in a special meeting on July 30, 1991 and did approve District Resolution No. ST-07-30-91-02 for FY-92 budget in the amount of \$308,123.44; and


WHEREAS, the Schuk Toak District Council requests the Legislative Council to ratify the budget; and

WHEREAS, the budgeted amount, upon ratification, be allocated to be expended in accordance with the attached approved budget.

NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does hereby approve the FY-92 budget of the Schuk Toak District, in the amount of \$308,123.44 to be expended in accordance with the attached budget.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 25th. day of September, 1991 at a meeting at which a quorum was presented with a vote of 1,444.0 FOR; -0- AGAINST; -0- NOT VOTING; and 280.0 [11] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
