

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the continued operations of the Legislative
Branch pending the approval of the FY-92 budget)**

3 **WHEREAS, the Legislative Council did convene into a Special Session on**
4 **September 23-25, 1991 for the purpose of adopting budgets for the**
5 **various Executive Departments, and the respective Branches, and;**

6 **WHEREAS, the council reviewed and adopted budgets for the Executive and**
7 **Judicial Branches, but were unable to approve a budget for the**
8 **Legislative Branch, and;**

10 **WHEREAS, the proposed Legislative Branch budget, in the amount of**
11 **\$849,110.76, has been scheduled for review during a Special Session**
12 **to be held on September 30, 1991, and;**

13 **WHEREAS, the current authority of the Legislative Branch to incur cost and**
14 **expend funds will expire at 12:00 midnight, September 30, 1991,**
15 **and;**

17 **WHEREAS, any proposed legislative budget adopted during the September 30,**
18 **1991 Special Session be subject to a 48 hour Executive review which**
19 **will extend into the 1992 Fiscal Year beyond the current spending**
20 **authority of the Legislative Branch, and:**

21 **WHEREAS, it would not be in the best interest of the Nation for the Legislative**
22 **Branch to shut down operations during the 48 hour Executive review**
23 **period.**

25 **NOW, THEREFORE, BE IT RESOLVED, by the Tohono O'odham Legislative**
26 **Council the Legislative Branch is hereby authorized to continue**
27 **incurring cost and expend funds for its regular operations until a**
28 **budget has been adopted.**

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 30th day of September, 1991 at a meeting at which a quorum was present with a vote of 1,660.5 FOR; -0- AGAINST; 63.5 NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


