3 **WHEREAS,** *spending authority for the 1991 fiscal year for the Legislative Branch*  
4 *ends at midnight September 30, 1991; and*

5  
6 **WHEREAS,** *it is necessary for the continued administration of the Legislative*  
7 *Branch to adopt an operating budget, to approve spending authority,*  
8 *and to appropriate funds for FY-1992; and*

9 **WHEREAS,** *the Legislative Branch has prepared and presented a budget that*  
10 *reflects the needs of the Branch for FY-1992, said budget is attached*  
11 *hereto and incorporated by reference; and*

13 **WHEREAS,** *the Legislative Council has reviewed this budget and recommended its*  
14 *approval and adoption.*

15 **NOW, THEREFORE, BE IT RESOLVED** *by the Legislative Council of the Tohono*  
16 *O'odham Nation that it hereby approves the FY-1992 budget*  
17 *submitted by the Legislative Branch. It is recognized that Payroll*  
18 *Taxes for Legislative Branch employees (in the amount of 12% of*  
19 *salaries) are included in this budget, and that Employee Benefits for*  
20 *all three branches (in the amount of 16% of salaries) are to be part of*  
21 *the Executive Branch budget.*



23 **BE IT FURTHER RESOLVED** *that funds in the amount of \$849,110.76 are*  
24 *hereby appropriated from the FY-1992 General Revenues of the*  
25 *Nation to carry out the activities supported by this budget.*
