1 RES. NO. <u>91-447</u> 2 WHEREAS. the Budget and Finance Committee of the Legislative Council has 3 reviewed the Projected Revenues for FY 1992; and 4 WHEREAS, the Committee recommends the adoption of a revised Projected 5 Revenues for FY '92; and 6 WHEREAS, the Legislative Council has approved an indirect cost rate charged 7 8 against all grants and contracts which is not fully recognized in the 9 projected revenues; and 10 WHEREAS, it is necessary to identify the full amount of indirect cost for inclusion 11 of the total projected revenues of the Nation. 12 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that 13 the Projected Revenues be increased from \$8,060,000.00 to 14 15 \$8,805,000.00, provided that the Budget & Finance Committee 16 investigate and identify all indirect costs for inclusion into the 17 projected revenues. 18 19 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on 20
