

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Tohono O'Odham Revised Projected Revenues FY 1992)**

2 **WHEREAS, the Budget and Finance Committee of the Legislative Council has**  
3 **reviewed the Projected Revenues for FY 1992; and**

4 **WHEREAS, the Committee recommends the adoption of a revised Projected**  
5 **Revenues for FY '92; and**

6  
7 **WHEREAS, the Legislative Council has approved an indirect cost rate charged**  
8 **against all grants and contracts which is not fully recognized in the**  
9 **projected revenues; and**

10 **WHEREAS, it is necessary to identify the full amount of indirect cost for inclusion**  
11 **of the total projected revenues of the Nation.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**  
14 **the Projected Revenues be increased from \$8,060,000.00 to**  
15 **\$8,805,000.00, provided that the Budget & Finance Committee**  
16 **investigate and identify all indirect costs for inclusion into the**  
17 **projected revenues.**

19 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**  
20 **the 30th. day of September, 1991 at a meeting at which a quorum was present with**  
21 **a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant**  
22 **to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution**  
23 **of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January**  
24 **18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
25 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**  
26 **(48 Stat. 984).**
