4 **supplementary budgets and appropriated funds for certain Programs**
5 **and Departments of the Tohono O'odham Nation; and**

8 **Taxes, but no provision for Employee Benefits; and**

9 **WHEREAS, the cost of Employee Benefits for Programs with approved**
10 **supplementary budgets is shown below:**


