3 **amount of funds that is in question; and**

4 **WHEREAS, the Baboquivari District Council recognizes that it will not be able to**  
5 **have the FY 1992 Budget completed by October 01, 1991; and**

7 **WHEREAS, Baboquivari District Council is hereby requesting an extension for the**  
8 **employees of the District and village workers.**

9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**  
10 **the Baboquivari District is hereby authorized to continue to incur cost**  
11 **and expend funds for its regular operations until a budget has been**  
12 **adopted.**



16 **a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant**  
17 **to the powers vested in the Council by Section 1 (d)(3) of Article VI of the**  
18 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**  
19 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**  
20 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**  
21 **1934 (48 Stat. 984).**


