(Pisinemo District Extension Budget)**

2 **WHEREAS, Pisinemo District's budget for FY-1992 is still in discussion; and**
3 **WHEREAS, the Pisinemo District Council recognizes that the FY-1992 budget will**
4 **not be able to be completed by October 1, 1992; and**
5 **WHEREAS, due to the short time frame the Pisinemo District did not do a financial**
6 **analysis for the two (2) months; and**
7 **WHEREAS, Pisinemo District is hereby requesting an extension for the two (2)**
8 **months.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
11 **the Pisinemo District is hereby authorized to continue to incur costs**
12 **and expend funds for its regular operations until a budget has been**
13 **adopted.**

15 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
16 **the 30th. day of September, 1991 at a meeting at which a quorum was present with**
17 **a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 01 ABSENT, pursuant**
18 **to the powers vested in the Council by Section 1 (d)(3) of Article VI of the**
19 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**
20 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
21 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**
22 **1934 (48 Stat. 984).**
