5 Constitution of the Tohono O'Odham Nation, and that their applications
6 are approved, as herein above indicated.

8 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the
9 Tohono O'Odham Nation reduce this final determination in writing
10 regarding each of the foregoing applications for enrollment in accordance
11 with Section 3 (c) of Article III of the Enrollment Ordinance; give notice of
12 this Council's determination in accordance with Section 4 of Article III of
13 the Enrollment Ordinance; and place the names of each applicant upon the
14 membership roll of the Tohono O'Odham Nation in accordance with Article
15 V of the Enrollment Ordinance.

17 The foregoing Resolution was passed by the Tohono O'Odham Council on the 7th.
18 day of October, 1991 at a meeting at which a quorum was present with a vote of
19 1,447.5 FOR; -0- AGAINST; 63.5 NOT VOTING; and 213.0 [6] ABSENT, pursuant
20 to the powers vested in the Council by Section 1 of Article II and Section 1 (h) of
21 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
22 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
the Act of June 18, 1934 (48 Stat. 984).
