

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Revenue and Expense Budgets of O'odham Construction and Materials and Appropriating \$352,663 to the OCM Budget and \$27,825 to the Employee Benefit Budget)**

4 **WHEREAS, a financial emergency exists that forces O'odham Construction and**
5 **Materials (OCM) to request action by the Legislative Council of the**
6 **Tohono O'Odham Nation to authorize expenditure of funds; and**

7 **WHEREAS, OCM was granted a charter, and has an approved plan of operation,**
8 **pursuant to Resolution No. 58-80; and**

9 **WHEREAS, OCM has operated as a departmental unit of the Tohono O'odham**
10 **Nation under Resolution Nos. 84-88 and 390-90; and**

11 **WHEREAS, OCM wishes to continue operating as a department for the FY-1992,**
12 **until a revised plan of operation can be approved by the Legislative**
13 **Council of the Tohono O'odham Nation; and**

14 **WHEREAS, OCM has prepared a budget that shows expenses of \$352,663 and**
15 **projected revenues of \$262,000 for the full 1992 Fiscal Year, and this**
16 **budget has been reviewed and approved by the Executive Office and**
17 **the OCM Oversight Committee.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Legislative Council of the Tohono**
21 **O'odham Nation that:**

22 **1.) The expense budget of \$352,663 is approved, and that amount**
23 **is appropriated from the General Revenues of the Tohono O'odham**
24 **Nation to support the activities described in that budget.**

25 **2.) The amount of \$27,825.00, which is 16% of proposed salaries,**
26 **is appropriated to the budget of the Executive Office to provide**
27 **employee benefits for OCM employees.**

3.) All revenues due from OCM's activities will be credited to the
General Revenues of the Tohono O'odham Nation.

BE IT FURTHER RESOLVED that the charter and plan of operation granted in
Resolution 58-80 are hereby rescinded, and all prior Resolutions which
are inconsistent with this Resolution shall be null and void.

BE IT FURTHER RESOLVED that OCM's obligation under Resolution No. 390-90 to
repay \$117,217 is still required.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on
the 8th day of October, 1991 at a meeting at which a quorum was present with a
vote of 1,660.5 FOR; 63.5 AGAINST; -0- NOT VOTING; and 03 ABSENT, pursuant
to the powers vested in the Council by Section 1 (d) of Article VI of the Constitution
of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January
18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984).






