WHEREAS, by Legislative Order No. 143-90, the Legislature amended Public Hearings Section 1.E of the Legislative Rules and Procedures to read as follows:

- 1. During the first General Session of the Legislature, following the election, the Legislature shall schedule and conduct public hearings to get input from the membership to set goals and objectives for the Tohono O'odham Nation, and to report to the membership the status of the previous goals and objectives.**
- 2. The Public Hearings shall be scheduled every election year.**
- 3. The Public Hearings shall be scheduled to cover the four directions, North, South, East, West and shall be rotated among the Districts every election year. A final Public Hearing shall be scheduled in Sells.**
- 4. The minutes of the Public Hearings shall be presented to the Legislature for review and action in their respective Legislative Committees.**
- 5. The Legislative Committees may hold public hearings to obtain public input regarding their specific responsibilities and areas of jurisdiction; and**

WHEREAS, upon the Rules Committee's presentation of a proposed Public Hearings Schedule to the Legislative Council, the Legislature recommended that hearings be held within each of the Nation's Districts; and

WHEREAS, the Legislative Rules Committee did provide each district with an opportunity to select a Public Hearing date; and

WHEREAS, the Rules Committee is recommending that the following ten (10) Public Hearings be conducted:

of 1,452.0 FOR; 136.0 AGAINST; 136.0 NOT VOTING; and 07 ABSENT, pursuant
to the powers vested in the Council by Section 1 (a) of Article VI of the Constitution
of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January
18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
(48 Stat. 984).**


