Gu vo District Governing Council reviewed and approved the attached 3 budget for fiscal year 1992, to begin October 1, 1991 and to end on 4 5 September 30th, 1992, in the total amount of \$86,456.96, which 6 does not exceed the amount available, and: 7 WHEREAS. the Budget as approved by the Governing Council distributes 8 \$12,000.00 to the Communities of the Gu vo District for community 9 projects and expenses, and; 10 11 WHEREAS, due to untimely notice of the Distribution, the communities of Pia oik, 12 Gu vo and Kukatch have been unable to schedule community 13 meetings to develop and adopt their respective budgets, and; 14 WHEREAS. the Ali chugk Community did prepare and present a budget for the 15 coming Fiscal year and further requested that \$6,000.00 of their 16 funds be held in reserve in an interest bearing account, and; 17 18 WHEREAS, the Legislative Council concurs with the budgets presented and 19 hereby approves. 20 NOW THEREFORE BE IT RESOLVED, BY THE TOHONO O'ODHAM LEGISLATIVE 21 **COUNCIL THAT:** 22 1. The Gu vo District Fy-92 Budget, attached, is hereby approved 23 in the amount \$86,456.96, retroactive to October 1, 1991 and 24 25 to end on September 30, 1992;
