

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing Negotiation of a Contract Between the
Tohono O'odham Nation and Ducheneaux, Gerard and Associates)**

3 **WHEREAS,** *the Tohono O'odham Nation recognizes the need to obtain legislative*
4 *and administrative advocacy services in regard to program and*
5 *services of the Federal Government of the United States of America;*
6 *and*

7 **WHEREAS,** *the firm of Ducheneaux, Gerard and Associates has proposed to*
8 *provide such services in fiscal year 1992, including: to advise the*
9 *Nation regarding Federal initiatives; to act as liaison with the Federal*
10 *Executive and Legislative Branches; to arrange meetings with Federal*
11 *Officials; to provide general quarterly reports on topics of interest to*
12 *the Nation; to provide specific reports on services provided directly to*
13 *the Nation; and*

14 **WHEREAS,** *the cost of such services shall be limited to less than \$30,000 in*
15 *fiscal year 1992; and*

16 **WHEREAS,** *funds in this amount have been appropriated by the Legislative*
17 *Council of the Tohono O'odham Nation for the purpose of obtaining*
18 *these services in fiscal year 1992 Administrative Provision budget of*
19 *the Executive Branch.*

20 **NOW, THEREFORE, BE IT RESOLVED** *that the Legislative Council of the Tohono*
21 *O'odham Nation hereby accepts the proposal of Ducheneaux, Gerard*
22 *and Associates to provide services to the Nation for the period of*
23 *October 1, 1991 to September 30, 1992.*

24 **BE IT FURTHER RESOLVED** *that the Tohono O'odham Nation's Officials,*
25 *to wit: the Chairman, Vice Chairman and any designated official are*
26 *hereby authorized to negotiate and execute the contract for services,*
27 *provided however, that any amendments affecting the funding levels*
28 *of the contract shall be submitted for further prior approval by the*
Legislative Council.


The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10th. day of October, 1991 at a meeting at which a quorum was present with a vote of 1,558.5 FOR; -0- AGAINST; 59.5 NOT VOTING; and 106.0 [7] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




