

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving an Attorney Contract with the Law Firm of  
Gover, Stetson & Williams for Fiscal Year 1992)**

3 **WHEREAS,** *during fiscal year 1991 the law firm of Gover, Stetson & Williams was*  
4 *engaged by Attorney Contract (as amended by Amendment Nos. 1*  
5 *and 2 thereto) to assist the Attorney General in providing legal*  
6 *representation to the Tohono O'odham Nation in connection with the*  
7 *Nation's interests under the Southern Arizona Water Rights*  
8 *Settlement Act of 1982 ("SAWRSA") and with respect to water rights*  
9 *claims in the Sif Oidak District; and*

11 **WHEREAS,** *the Attorney Contract is for a term which ended on September 30,*  
12 *1991; and*

13 **WHEREAS,** *the Legislative Council approved a Fiscal Year 1992 Operating Budget*  
14 *for the Office of Attorney General which included an allocation of*  
15 *\$145,000 for an Attorney Contract with Gover, Stetson & Williams*  
16 *to continue the legal representation provided to the Nation; and*

18 **WHEREAS,** *the Attorney General and the Domestic Affairs Committee recommend*  
19 *approval of an Attorney Contract with Gover, Stetson & Williams for*  
20 *Fiscal Year 1992 in the amount of \$145,000.*

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

23 1. *The Attorney Contract between the Tohono O'odham Nation and*  
24 *the law firm of Gover, Stetson & Williams is approved for Fiscal*  
25 *Year 1992 in the amount of \$145,000 and in the form attached*  
26 *hereto.*

28 2. *The Chairman of the Nation is authorized and directed to execute*  
*the Attorney Contract.*






