3 **WHEREAS,** *during fiscal year 1991, the Office of Indian Programs ("OIP") was*  
4 *engaged by Legal Services Consultant Contract (the "Contract") to*  
5 *assist the Attorney General in providing legal advice and*  
6 *representation in connection with the Tohono O'odham Nation's land*  
7 *and water claims in Mexico; and*

8  
9 **WHEREAS,** *the term of the Contract ended on September 30, 1991; and*

10 **WHEREAS,** *there is a continued need to maintain contract legal services in*  
11 *connection with the Nation's claims in Mexico; and*

12 **WHEREAS,** *the Legislative Council approved a fiscal year 1992 Operating Budget*  
13 *for the Office of Attorney General which included an allocation of*  
14 *\$50,000 for a Contract with OIP to continue its legal assistance to*  
15 *the Nation concerning the Mexico claims; and*

16  
17 **WHEREAS,** *the Attorney General and the Domestic Affairs Committee recommend*  
18 *approval of a Contract with OIP for fiscal year 1992 in the amount of*  
19 *\$50,000.*

20 **NOW, THEREFORE, BE IT RESOLVED THAT:**

  2. *The Chairman of the Nation is authorized and directed to execute the foregoing Contract.*


