NO. 91-471 2 WHEREAS, during fiscal year 1991 the law firm of Linden, Chapa & Fields was 3 engaged by Attorney Contract (as amended by Amendment Nos. 1 5 and 2 thereto) to assist the Attorney General in providing legal 6 representation to the Tohono O'odham Nation with respect to two 7 lawsuits pending in the Nation's Tribal Court; and 8 WHEREAS, the Attorney Contract is for a term which ended on September 30, 9 1991; and 10 WHEREAS, the remaining lawsuit within the scope of the Attorney Contract is 11 12 Hickiwan District v. Arizona District Council of Assemblies of God 13 Church (the "Hickiwan Case"); and 14 WHEREAS. the Legislative Council approved a fiscal year 1992 Operating Budget 15 for the Office of Attorney General which included an allocation of 16 \$5,000 for an Attorney Contract with Linden, Chapa & Fields to 17 18 continue representation in the Hickiwan Case; and 19 WHEREAS. the Attorney General and the Domestic Affairs Committee recommend 20 approval of an Attorney Contract with Linden, Chapa & Fields in the 21 amount of \$5,000. 22 NOW, THEREFORE, BE IT RESOLVED THAT: **2**3 1. The Attorney Contract between the Tohono O'odham Nation and 24 25 the law firm of Linden, Chapa & Fields is approved for fiscal year 26 1992 in the amount of \$5,000 and in the form attached hereto. 27 2. The Chairman of the Nation is authorized and directed to execute

the Attorney Contract.
