NO. 91-472 2 WHEREAS. pursuant to Resolution No. 417-90 the Legislative Council approved 3 an Attorney Contract with Abby Abinanti to provide legal advice and representation to the Tohono O'odham Nation with respect to the law 5 suit captioned In the Matter of Raymond Salas (the "Salas Case") 6 which is pending in California Superior Court, Sacramento County; 7 8 and 9 WHEREAS, the Salas Case involves the Nation's rights under the Indian Child 10 Welfare Act; and 11 WHEREAS, the Attorney Contract was for a term which ended on September 30, 12 1991; and 13 WHEREAS, the Salas Case is expected to be concluded soon without the need for 14 15 significant attorney services; and 16 WHEREAS. the Legislative Council approved an Operating Budget for the Office 17 of Attorney General for fiscal year 1992 which included an allocation 18 of \$2,000 to fund an Attorney Contract with Abby Abinanti during 19 this fiscal year; and 20 WHEREAS. the Attorney General has proposed an Attorney Contract with Abby 21 **22**. Abinanti, a copy of which is attached hereto, under which she would 23 continue representation of the Nation in the Salas Case; and 24 WHEREAS, the Domestic Affairs Committee has recommended approval of the **25** Attorney Contract by the Council. 26
