3 **WHEREAS, the Tohono O'odham Legislative Council did by Resolution No. 91-474**
4 **approve Modification No. 1 to the Fiscal Year 1992 Operating Budget**
5 **of the Office of Attorney General and Appropriated \$4,221 to the**
6 **General Account for Employee Benefits; and**

8 **WHEREAS, the Tohono O'Odham Legislative Council also by Resolution No.**
9 **91-475 approved Modification No. 2 and appropriated an additional**
10 **\$29,544 to the Fiscal Year 1992 Operating Budget of the Office of**
11 **Attorney General, and appropriated \$9,672 to the General Account for**
12 **Employee Benefits; and**

14 **WHEREAS, upon presentation of Resolution Nos. 91-474 and 91-475 to the**
15 **Chairman of the Tohono O'Odham Nation, he did disapprove thereof**
16 **and returned it to the Council with his objections in accordance with**
17 **the provisions of Article VII, Section 5 of the Constitution of the**
18 **Tohono O'Odham Nation; and**

20 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed the Chairman's**
21 **objections and after consideration, again voted to pass Resolution**
22 **Nos. 91-474 and 91-475.**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council**
24 **does hereby override the Chairman's veto of Resolution Nos. 91-474**
25 **and 91-475 by a vote of two-thirds (2/3) of the votes cast.**

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the 22ND. day of OCTOBER, 1991 at a meeting at which a quorum was present with a vote of 762.5 FOR; 836.5 AGAINST; 125.0 NOT VOTING; and -0- ABSENT, failed to pass because it did not receive a majority of two-thirds (2/3) of the votes cast, [1,066.0], as required by Section 2 of Article V of the Constitution of the Tohono O'Odham Nation.
