24 **December 1991 General Session.**



6 **pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the**
7 **Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation**
8 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
9 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**
10 **1934 (48 Stat. 984).**
