2 WHEREAS, the Tohono O'odham Legislative Council's agenda for October 28,

7 Nation and the San Lucy District that it be addressed in closed
8 session; and


9 WHEREAS, in accordance with Article I, Section 1.F a motion was made to
10 formally close the session to address this item.

11 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that
12 it hereby proceeds into closed session to address the San Lucy Farm
13 in Lieu Tax Issue listed on this day's agenda.

15 BE IT FURTHER ORDERED that the Attorney General's Office, San Lucy District
16 Officials; and the Tohono O'Odham Farming Authority Board are
17 hereby allowed in the closed session

20 The foregoing Order was passed by the Tohono O'Odham Legislative Council on the
21 28TH. day of OCTOBER, 1991 at a meeting at which a quorum was present with
22 a vote of 1,431.0 FOR; 127.0 AGAINST; 166.0 NOT VOTING; and 04 ABSENT,
23 pursuant to the powers vested in the Council by Section 1 (a) of Article VI of the
24 Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
25 Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of
27 the Act of June 18, 1934 (48 Stat. 984).


