2 **WHEREAS, the Baboquivari District Council has considered and reviewed its**
3 **proposed activities for FY '92 and has prepared a budget to cover**
4 **anticipated costs and expenses; and**

6 **WHEREAS, the Baboquivari District Council did adopt a proposed budget for FY**
7 **'92 in the amount of \$115,609.55 said budget to begin on**
8 **October 01, 1991 and end on September 30, 1992; and**

9 **WHEREAS, there is sufficient funds to cover the total Fiscal Year 1992 Budget;**

11 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed the proposed**
12 **budget and approves of same.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that**
15 **it hereby approves the Baboquivari District budget to be expended in**
16 **accordance with the attached budget.**

17 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on**
18 **the 4th. day of November, 1991 at a meeting at which a quorum was present with**
19 **a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and 02 ABSENT, pursuant**
20 **to the powers vested in the Council by Section 1 (d)(3) of Article VI of the**
21 **Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**
22 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian**
23 **Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18,**
24 **1934 (48 Stat. 984).**
