4 **through various programs and services designed to meet their special**  
5 **needs; and**

7 **WHEREAS, the Title XX - Child Day Care Services program has been successfully**  
8 **operated through the Early Childhood Program and has served many**  
9 **young Tohono O'Odham children; and**

10 **WHEREAS, the Tohono O'Odham Title XX - Child Day Care Services Program has**  
11 **received a reduction in funding in the amount of \$1,052.00; and**

13 **WHEREAS, any amendments affecting the funding or funding levels of the**  
14 **contract shall be submitted for review and approval by the Tohono**  
15 **O'Odham Legislative Council; and**

16 **WHEREAS, an amendment has been submitted for review and approval by the**  
17 **Title XX - Child Day Care Services Program.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative Council**  
20 **does hereby approve the amendment of the Title XX - Child Day Care**  
21 **Services Program and authorizes expenditures in accordance with the**  
22 **attached budget.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the**  
24 **Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice**
