3 **WHEREAS, the Tohono O'Odham Nation has operated the Water Projects**
4 **Office to provide administrative services under a P. L. 93-638**
5 **contract with the Bureau of Reclamation for the development of**
6 **projects in the Schuk Toak and San Xavier Districts through**
7 **Contract No. 8-CS-32-00380 and Contract No. 8-CS-30-04830;**

11 **WHEREAS, the Tohono O'Odham Legislative Council by means of**
12 **Resolutions 91-284 and 91-285 authorized one year extensions of**
13 **the above mentioned contracts and approved budgets for FY 1992**
14 **to enable the continued operation of the Water Projects Office**
15 **through the P. L. 93-638 Contracts; and**

18 **WHEREAS, the Tohono O'Odham Legislative Council by means of Resolution**
19 **91-488 provided interim funding for the first quarter of FY 1992**
20 **from FY 1992 General Revenues to maintain operation of the**
21 **Water Projects Office when the Bureau of Reclamation did not**
22 **execute the one year extensions and budgets; and**

24 **WHEREAS, the Bureau of Reclamation has not provided requested contract**
25 **extensions to the Tohono O'Odham Nation in a manner consistent**
26 **with the statutory requirements of Section 102 of P. L. 93-638, as**

3 **WHEREAS, the Water Projects Office has submitted a budget for staff salaries**
4 **and support costs to be approved in the interim while the contracts**
5 **are negotiated with the Bureau of Reclamation; and**

7 **WHEREAS, the Water Projects Office is requesting from the Tohono**
8 **O'Odham Nation interim funding in the amount of \$78,600 to**
9 **enable the operations of the office to continue for one quarter**
10 **(1/01/92 to 3/31/92) or until the requested contract modifications**
11 **are provided to the Tohono O'Odham Nation. Reimbursement for**
12 **such funds will be sought through the Bureau of Reclamation**
13 **once the contract extensions are executed.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**
18 **Council that it does hereby approve the funding request and**
19 **authorizes expenditures in accordance with the attached budget.**

21 **BE IT FURTHER RESOLVED that funds in the amount of \$78,600 are hereby**
22 **approved from the FY 1992 General Revenues of the Nation.**

23 **BE IT FURTHER RESOLVED that the amount of \$9,163 which is 16% of**
24 **proposed salaries, is appropriated to the budget of the Executive**
25 **Office to provide employee benefits for Water Projects Office**
26 **employees.**

BE IT FINALLY RESOLVED that reimbursement for such funds advanced by
the Tohono O'Odham Nation will be sought through the Bureau
of Reclamation.

The foregoing Resolution was passed by the Tohono O'Odham Legislative
Council on the 16TH day of JANUARY, 1992 at a meeting at which a quorum
was present with a vote of 1,364.0 FOR; -0- AGAINST; 119.0 NOT VOTING;
and 241.0 [9] ABSENT, pursuant to the powers vested in the Council by Section
1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation,
adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,
1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






