3 **WHEREAS, the Tohono O'Odham Legislative Council did, by Resolution No.**
4 **91-203, authorize officials of the Nation to accompany the Vigida**
5 **Ceremony officials in presenting to the Mexican government**
6 **officials the O'Odham's concern regarding the proposed**
7 **archaeological zone in the Quitovac area; and**

9 **WHEREAS, the Legislative Council recognizes the immediate need to retain a**
10 **Consultant in Mexico City to provide the services as listed in the**
11 **Service Agreement in the form attached hereto; and**

13 **WHEREAS, a two month Agreement was entered into with Isidoro Asse, from**
14 **November 11, 1991 to January 11, 1992; and**

16 **WHEREAS, the Legislative Council by Legislative Order No. 91-541 instructed**
17 **the immediate termination of the aforementioned Agreement until**
18 **further discussions; and**

20 **WHEREAS, the Legislative Council is now in agreement to retain a consultant**
21 **in Mexico City to provide legislative administrative advocacy**
22 **services to the Nation through September 30, 1992.**

- 2) *it does hereby authorize and direct that the Chairwoman of the Legislative Council and Chairman of the Nation to execute the Agreement.*

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 30TH. day of JANUARY, 1992 at a meeting at which a quorum was present with a vote of 716.5 FOR; 445.5 AGAINST; 252.0 NOT VOTING; and 310.0 [6] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




