10 **WHEREAS, the O'Odham in Mexico Office, nor its representative, were not**
11 **present to inform the Council on this item; and**

12 **WHEREAS, several members of the Legislative Council deemed it necessary**
13 **that all documentation concerning the Legal Counsel Contract be**
14 **submitted for Legislative Council's review.**

16 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'Odham Legislative**
17 **Council hereby tables item #4 (Legal Counsel Contract for**
18 **O'Odham in Mexico) to be addressed during the February**
19 **General Session.**

21 **BE IT FURTHER ORDERED that the Tohono O'Odham Legislative Council**
22 **hereby recesses its January 30, 1992 Special Session.**


