The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the <u>3RD.</u> day of <u>FEBRUARY</u>, <u>1992</u> at a meeting at which a quorum was present with a vote of <u>1,541.0</u> FOR; <u>-0-</u> AGAINST; <u>183.0</u> NOT VOTING; and <u>02</u> ABSENT, pursuant to the powers vested in the Council by <u>Section 1 of Article II</u> and <u>Section 1 (h) of Article VI</u> of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
