No. 51-90 authorizing 4 the application for Community Development Block Grant funds 5 6 for specified projects; and 7 WHEREAS, Housing and Urban Development-Community Development Block 8 Grant awarded the Sil Nakya, and Sikol Himatke proposal for 9 10 funding; and 11 WHEREAS, the Tohono O'odham Nation also adopted a priority listing 12 (Resolution No. 125-90), presented by Indian Health Services, 13 14 which was submitted to Environmental Protection Agency for 15 funding consideration under the 1990 Indian Set aside Grant 16 Program; and 17 WHEREAS, Environmental Protection Agency notified the Nation that they 18 19 have identified the Sil Nakya project to receive grant funds, under 20 the Indian Set-Aside Program, for construction of a wastewater 21 22 collection and treatment facility for the Sil Nakya Community in 23 the Schuk Toak district; and 24 WHEREAS. Environmental Protection Agency funds in the amount of 25 26 \$416,000.00 has been set aside for the Sil Nakya project and 27 \$40,000.00 is made available for planning and preliminary 28 design; and
