1992 contract with Indian Health Services; and

WHEREAS, as a result of the negotiation the Behavioral Health Services has submitted a revised scope of work and budget modification #1 for the Alcoholism component in order to provide services to the O'Odham Community.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative

Council does hereby approve and request the Indian Health

Services to modify the FY 1992 Behavioral Health Services

contract in accordance to the attached scope of work and budget

modification #1 for the Alcoholism Component.
