4 **O'Odham Psychological Services/Children's Initiative Program**  
5 **under FY 1992 P.L. 93-638 contract with the Public Health,**  
6 **Indian Health Services; and**

9 **WHEREAS, such tribal operation has been successful and beneficial to the**  
10 **Tohono O'Odham Nation and its people; and**

11 **WHEREAS, the Tohono O'Odham Nation has been informed of additional**  
12 **allocation to support the Children's Initiative; and**

14 **WHEREAS, the Tohono O'Odham Psychological Services has submitted for**  
15 **review and approval a budget modification for the Children's**  
16 **Initiative Component in order to provide services to the O'Odham**  
17 **Community.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
20 **Council that it does hereby approve the amendment of the Tohono**  
21 **O'Odham Psychological Services, Children's Initiative Component**  
22 **and authorizes expenditures in accordance with the attached**  
23 **budget.**


