4 **WHEREAS, the Legislative Council of the Tohono O'Odham Nation is**
5 **authorized by the Tohono O'Odham Constitution Article VI,**
6 **Powers of the Tohono O'Odham Council, Section 1.d.3,**
7 **Paragraph 3 of d asserts: to adopt, approve and amend annual**
8 **budgets and to authorize the expenditure of funds in accordance**
9 **with these budgets; and**

12 **WHEREAS, through research and consultation provided by the Director of**
13 **Government Operations, to the Executive Committee, the Nation's**
14 **Chairman and the Executive Committee have advised that the**
15 **Nation's officials and employees would benefit from a 3% cost of**
16 **living adjustment to keep pace with inflation and employment**
17 **practices in the general area of the Nation.**

20 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the**
21 **Tohono O'Odham Nation hereby approves a 3% cost of living**
22 **adjustment for the Nation's officials and employees effective**
23 **October 01, 1992 for the Nation's Fiscal Year 1993.**

25 **BE IT FURTHER RESOLVED that the Executive Branch of the Nation is to**
26 **advise that all budgets prepared and submitted to this Legislative**
27 **Council for FY 1993 appropriations should include this 3% Cost**




The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. day of MARCH, 1992 at a meeting at which a quorum was present with a vote of 1,387.0 FOR; 211.0 AGAINST; 126.0 NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
