WHEREAS, federal funding may be available through the Bureau of Indian Affairs ("BIA"), under P. L. 93-638 or other contractual arrangements, to pay for the costs of technical experts and attorney services in connection with the water claims of the Tohono O'Odham Nation in the Sif Oidak District, and under the Southern Arizona Water Rights Settlement Act of 1982 ("SAWRSA") and related lawsuit entitled U.S. v. Tucson; and

WHEREAS, the Nation has committed in excess of \$240,000 in Tribal funds to engage technical experts to conduct studies associated with these claims; and

WHEREAS, for fiscal year 1992 the Nation appropriated and obligated by contract \$145,000 for special water counsel in connection with these claims; and

WHEREAS, additional funding for technical and legal services is an essential condition to formulating settlements and avoiding the substantial time and expense of litigation; and

- 2. The Chairman of the Nation is authorized and directed to execute the Application on behalf of the Nation.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 12TH. day of MARCH, 1992 at a meeting at which a quorum was present with a vote of 941.0 FOR; 435.0 AGAINST; 348.0 NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1 (d), (f), (i)(2), 2(d) of Article VI and Section 2 of Article XVII of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
