3 **WHEREAS, Low Income Home Energy Assistance funds have been made**  
4 **available to the Tohono O'Odham Nation for FY 1993 through**  
5 **the State of Arizona, Department of Economic Security, Low**  
6 **Income Home Energy Assistance Program; and**

7  
8 **WHEREAS, the Tohono O'Odham Nation does meet the eligibility**  
9 **requirements; and**

10  
11 **WHEREAS, it is in the best interest of the Tohono O'Odham Nation to apply**  
12 **for FY 1993 Low Income Home Energy Assistance funds to assist**  
13 **needy families with their residential utility bills.**

14  
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**  
16 **Council does hereby approve the proposal to the State of Arizona,**  
17 **Department of Economic Security for FY 1993 Low Income Home**  
18 **Energy Assistance funding.**

19  
20 **BE IT FURTHER RESOLVED that the duration of the grant is July 1, 1992**  
21 **through June 30, 1993.**

23 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**  
24 **that the Tohono O'Odham Nation's officials, to wit: the**  
25 **Chairman, Vice Chairman and any designated official are hereby**  
26 **authorized to negotiate and execute the grant, provided however,**

3 the grant shall be submitted for further prior approval by this  
4 Council.

8 Council on the 13TH. day of MARCH, 1992 at a meeting at which a quorum  
9 was present with a vote of 1,617.0 FOR; -0- AGAINST; -0- NOT VOTING;  
10 and 107.0 [7] ABSENT, pursuant to the powers vested in the Council by Section  
11 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted  
12 by the Tohono O'Odham Nation on January 18, 1986; and approved by the  
13 Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,  
14 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).






