3 **WHEREAS, the Tohono O'Odham Nation has successfully operated a program**  
4 **for the elderly members of the Nation; and**

5 **WHEREAS, funding for the operation of the Elderly Program has been**  
6 **possible in part by Article VI of the Older American's Act of 1965**  
7 **as amended; and**

9 **WHEREAS, the Elderly Program desires to seek continued funding by**  
10 **submitting a proposal to the Office of Human Development**  
11 **Services, Administration on Aging; and**

13 **WHEREAS, the Elderly proposal will benefit elder members of the Tohono**  
14 **O'Odham Nation by providing for their nutritional and social**  
15 **support services.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
18 **Council that it does hereby approve the proposal for continued**  
19 **funding of the Elderly Program to provide services to eligible**  
20 **members of the Tohono O'Odham Nation.**

23 **BE IT FURTHER RESOLVED that the term of this grant shall commence on**  
24 **April 01, 1992 and end on March 31, 1994.**

25 **BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council**

*The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 13TH. day of MARCH, 1992 at a meeting at which a quorum was present with a vote of 1,617.0 FOR; -0- AGAINST; -0- NOT VOTING; and 107.0 [7] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*






