3 **WHEREAS, the Tohono O'odham Nation is presently operating the Johnson**  
4 **O'Malley Program under FY 1992 P.L. 93-638 contract with the**  
5 **Bureau of Indian Affairs; and**

7 **WHEREAS, the Tohono O'odham Nation has been informed of the FY 1992**  
8 **final allocation; and**

9  
10 **WHEREAS, such funds made available for obligation have reflected an**  
11 **increase in funding for FY 1992 in the amount of \$15,398.00;**  
12 **and**

14 **WHEREAS, any amendments affecting the funding or funding levels of the**  
15 **contract shall be submitted for review and approval by the**  
16 **Johnson O'Malley Program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative**  
19 **Council does hereby approve the amendment to the Johnson**  
20 **O'Malley contract and authorizes expenditures in accordance with**  
21 **the attached budget.**

23 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that**  
24 **the Tohono O'odham Nation's Officials, to wit: the Chairman,**  
25 **Vice Chairman and any designated official are hereby authorized**




