NO. 92-119 2 WHEREAS, the FY 1992 Budget for the Legislative Branch of the Tohono O'odham 3 Nation was approved by the Tohono O'odham Legislative Council; and 4 5 WHEREAS, the Legislative Officers have presented a request for modification of that 6 budget for the Council's review and consideration; and 7 WHEREAS, the modification provides for establishment of a new temporary secretarial 8 position to provide emergency support to the Legislative Branch; and 9 10 WHEREAS, the modification provides for two current staff to temporarily assume a 11 higher level of responsibility and pay; and 12 WHEREAS, the Tohono O'odham Legislative Council has reviewed and considered 13 this request. 14 15 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council 16 that it hereby approves the FY'92 Budget Modification No. 3 for the 17 Legislative Branch of the Tohono O'odham Nation and authorizes 18 expenditures in the form attached hereto. 19 20 BE IT FURTHER RESOLVED that the Executive Branch of the Nation, specifically 21 the Accounting Department, is authorized to execute this modification in 22 accordance with the intent of the Legislative Council. 23 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on 24 the 6TH day of April, 1992 at a meeting at which a quorum was present with a vote 25 of 1,671.0 FOR; 53.0 AGAINST; -0- NOT VOTING; and 05 ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(3) of Article VI of the Constitution

of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January

18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
