3 **WHEREAS, the Pisinemo District Council of the Pisinemo District on March 14,**
4 **1992 by District Resolution 01-92, approved their Six (6) Month District**
5 **Budget in the amount of Fifty Five Thousand Two Hundred Seven**
6 **Dollars and Forty Cents (\$55,207.40); and**

8 **WHEREAS, the Six (6) Month budget and budget period would be from April 01,**
9 **1992 to September 30, 1992; and**

10 **WHEREAS, the Pisinemo District Council did review and discuss the needs of the**
11 **people of Pisinemo District and the need to have a District Office with**
12 **an operating budget and District staff; and**

14 **WHEREAS, the Pisinemo District has sufficient funds in their account which is on**
15 **deposit with the Tohono O'odham Nation's Accounting Department to**
16 **cover their proposed budget; and**

18 **WHEREAS, the Tohono O'odham Legislative Council has reviewed the Pisinemo**
19 **District proposed budget and budget justification which is attached and**
20 **finds it in order.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council**
23 **that it hereby approves the Pisinemo District FY 1992 Six (6) Month**
24 **Budget request as presented in the amount of Fifty Five Thousand Two**
25 **Hundred Seven Dollars and Forty Cents (\$55,207.40) and authorizes**
26 **expenditures in accordance therewith.**

of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January
18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
Stat. 984).
