3 **WHEREAS, the Tohono O'odham Nation has declared Diabetes to be a top**
4 **health priority; and**

5 **WHEREAS, the Department of Health and Human Services has announced**
6 **competitive grant applications for fiscal year 1992 Tribal**
7 **Demonstration Projects for Diabetes Services for American**
8 **Indians and Alaska Native; and**

11 **WHEREAS, uncontrolled diabetes does cause complications including**
12 **blindness, kidney disease, cardiovascular disease, amputation and**
13 **premature death; and**

15 **WHEREAS, the occurrence of Type II diabetes and the complications of Type**
16 **II diabetes can be prevented or delayed by screening early**
17 **intervention and close control; and**

19 **WHEREAS, it is in the best interest of the Tohono O'Odham Nation to apply**
20 **for FY 1992 Tribal Demonstration Project for Diabetes Services**
21 **as set forth in the funding eligibility criteria; and**

23 **WHEREAS, the Tohono O'Odham Health Department does submit for review**
24 **and approval a proposal for Diabetes Screening Program for**
25 **services during fiscal year 1993 (09/01/92 - 08/31/93).**

Diabetes Screening proposal and authorizes expenditures in accordance to the attached budget.

BE IT FURTHER RESOLVED by the Tohono O'Odham Legislative Council that the Tohono O'Odham Nation's Officials, to wit: the Chairman, Vice Chairman and any designated official are hereby authorized to negotiate and execute the grant, provided however, that any amendments affecting the funding or funding levels of the grant shall be submitted for further prior approval by this council.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. day of APRIL, 1992 at a meeting at which a quorum was present with a vote of 1,503.0 FOR; -0- AGAINST; -0- NOT VOTING; and 221.0 [9] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
