- NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that \$1,523,882.36 is hereby identified and declared unexpended savings from the Nation's FY-91 General Funds appropriated budget.
- BE IT FURTHER RESOLVED that the funds declared unexpended \$1,500,000.00 be carried forward into the Nation's FY-92 Budget and be added to the revenue projections for FY-92 to that extent said funds remain available for appropriation by action of this Legislative Council.
- BE IT FINALLY RESOLVED that the remaining \$23,882.36 declared unexpended shall

 be placed in the Nation's Special Reserve Fund and remain there until

 further action of this Legislative Council.
- The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the <u>10TH</u> day of <u>April</u>, <u>1992</u> at a meeting at which a quorum was present with a vote of <u>1,511.0</u> FOR; <u>-0-</u> AGAINST; <u>-0-</u> NOT VOTING; and <u>213.0 [08]</u> ABSENT, pursuant to the powers vested in the Council by Section <u>1 (d)(2) & (3)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
