  Council that funds in the amount of \$13,931.00 be appropriated,

  for the purpose of increasing the budget of the Hia-Ced O'odham

  Program.
- BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that it hereby approve this amendment and authorizes expenditures in accordance with the attached budget.
