

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM COUNCIL**  
**(Tabling and referring Prosecutor's Office FY'92 Budget Modification No. 1**  
**to Appropriate Oversight Committees)**

**LEGISLATIVE ORDER NO. 92-173**

**WHEREAS,** *the Tohono O'odham Nation's Prosecutor's Office did submit a request to modify its FY 1992 Budget to the Tohono O'odham Legislative Council; and*

**WHEREAS,** *the Legislative Council did consider this matter in some detail; and*

**WHEREAS,** *several concerns and questions were raised during the Council's discussion of this matter.*

**NOW, THEREFORE, BE IT ORDERED** *by the Tohono O'Odham Legislative that the FY'92 Prosecutor's Office Budget Modification request be tabled and referred back to the appropriate oversight committees of the Legislature, including the Budget & Finance Committee, to address the concerns and questions raised.*

**BE IT FURTHER ORDERED** *that this request will be brought back for full Council consideration upon the completion of the ordered reviews by the appropriate oversight Committees.*

*The foregoing Order was passed by the Tohono O'Odham Legislative Council on the 5TH day of May, 1992 at a meeting at which a quorum was present with a vote of 754.0 FOR; 647.0 AGAINST; 323.0 NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section 1(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*




