

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Waiver of Indirect Cost for the FY 1993**  
**Family Preservation Program)**

3 **WHEREAS, the Tohono O'Odham Nation established a policy to require the**  
4 **inclusion of indirect costs in all third party funded agreements;**  
5  
6 **and**

7 **WHEREAS, the policy provides for an exception and waiver of the requirement**  
8 **by the Legislative Council if it is in the best interest of the Nation**  
9 **to do so, that is when the benefits to the Nation exceeds the need**  
10 **to collect the revenues from the funding agency; and**

11  
12 **WHEREAS, funding from the Bureau of Indian Affairs for the FY 1993 Title**  
13 **II Indian Child Welfare Act - Family Preservation Program is**  
14 **insufficient to cover both direct and indirect cost needs of the**  
15 **program.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative**  
19 **Council finds that it is in the best interest of the Nation to waive**  
20 **the indirect cost funding requirement for FY 1993 Family**  
21 **Preservation.**

23 **The foregoing Resolution was passed by the Tohono O'Odham Legislative**  
24 **Council on the 5TH day of May, 1992 at a meeting at which a quorum was**  
25 **present with a vote of 1,121.5 FOR; 373.5 AGAINST; -0- NOT VOTING;**  
26 **and 229.0 [05] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by**  
**the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6,**  
**1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
