

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Appropriating Funds for Major Renovations)**

WHEREAS, the following facilities owned by the Nation are in need of renovation and rehabilitation at the following estimated costs:

1.	Career Center (Re-roofing)	\$ 46,000.00
	Asbestos Abatement	5,000.00
2.	Enrollment Renovation & Rehabilitation	48,520.95
3.	Health (HVAC)	254,511.00
4.	Administration (Re-roofing)	104,500.00
	Asbestos Abatement	10,000.00
5.	Planning (Renovations & Rehabilitation)	19,334.00
6.	Atty. General (Renovation & Rehabilitation)	10,000.00; and

WHEREAS, renovation and repair of the Nation's facilities is necessary to allow for the continued effective and efficient administration of the programs and activities housed in those facilities; and

WHEREAS, it is expeditious to effect repairs, now, in order to minimize the extent of continued deterioration of the Nation's assets and increased costs associated with such continued deterioration; and

WHEREAS, it is in the best interest of the Nation to effect the necessary repairs and renovations.

NOW, THEREFORE, BE IT RESOLVED that Four Hundred Ninety Seven Thousand Eight Hundred Sixty Five dollars and Ninety Five cents (\$497,865.95) is hereby appropriated and set aside for completion of Major Renovations.

BE IT FURTHER RESOLVED that \$497,865.95 shall be utilized pursuant to the attached Major Renovations Budget, approved and authorized by this Resolution.

BE IT FINALLY RESOLVED that it is anticipated that the Major Renovations authorized by this Resolution will be completed within twelve (12) months of the date of this Resolution and that the funds appropriated and authorized by this Resolution shall remain in force until such a time as all Major Renovations have been completed.

The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 7TH day of May, 1992 at a meeting at which a quorum was present with a vote of 1,524.5 FOR; 63.5 AGAINST; 136.0 NOT VOTING; and 01 ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
