LEGISLATIVE ORDER NO. 92-187

WHEREAS, the Policies and Procedures of the Tohono O'odham Council in

Article I, Section 1.A, LEGISLATIVE CALENDAR, Subsections

1 & 3 states:

- 1. Prior to an official adjournment, the Legislative Council shall adopt a Legislative Calendar which shall commence on the first working day of June on which the Legislative Council will be called into Legislative Session. The Calendar shall specify dates for the general sessions, recess periods, recognized holidays, and the days of adjournment.
- 3. The Legislative Calendar shall be based only on working days and scheduled paid holidays; and
- WHEREAS, the Rules Committee has prepared a Legislative Calendar in accordance with the Policies and Procedures of the Tohono O'odham Legislative Council.

NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative

Council does hereby adopt the Legislative Calendar which

commences on June 01, 1992 and ends on May 31, 1993.

The foregoing Order was passed by the Tohono O'Odham Legislative Council on the <u>8TH</u> day of <u>May</u>, <u>1992</u> at a meeting at which a quorum was present with a vote of <u>1,006.5</u> FOR; <u>498.0</u> AGAINST; <u>53.5</u> NOT VOTING; and <u>166.0 [04]</u> ABSENT, pursuant to the powers vested in the Council by Section <u>1(a)</u> of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
