2 **WHEREAS, by Resolution Nos. 260-89 and 91-346 the Tohono O'odham**  
3 **Legislative Council appointed a Negotiating Committee for the**  
4 **purpose of negotiating a tribal-state compact with the State of**  
5 **Arizona for the operation of Class III gaming within the Tohono**  
6 **O'odham Nation; and**

9 **WHEREAS, by Resolution Nos. 331-90 and 92-095, the Tohono O'odham**  
10 **Nation established and renewed membership in the National**  
11 **Indian Gaming Association (NIGA), as recommended by the**  
12 **Commerce Committee; and**

13  
14 **WHEREAS, the Negotiating Team has submitted a budget for review by the**  
15 **Tohono O'odham Legislative Council for purposes of attending**  
16 **negotiating meetings with the State, National Indian Gaming**  
17 **Association Conferences (NIGA), and other Indian gaming-related**  
18 **conferences and/or meetings; and**

20 **WHEREAS, the Negotiating Team FY'92 budget submitted in the amount of**  
21 **\$19,000 is effective October 01, 1991 to September 30, 1992.**

23 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative**  
24 **Council that it hereby approves the Negotiating Team FY '92**  
25 **budget in the amount of \$19,000.**

27 **BE IT FURTHER RESOLVED that funds to cover the budget be allocated**  
28 **from the operating cost of the Bingo Revenues.**
