WHEREAS, Ms. Mayer has also filed a lawsuit in federal court against the Nation's personnel director, which case is docketed as Case No. CIV-91-320-TUC-RMB in the United States District Court for the District of Arizona, in which Ms. Mayer alleges that in processing her grievance according to the Nation's Personnel and Procedure Manual she was denied due process of law; and

WHEREAS, to avoid the time and expense of continuing the defense of the grievance proceeding and federal court action, the Nation's insurance carrier is prepared to make an offer of settlement of these claims.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Nation's Vice Chairman, Sylvester Listo, in consultation with the Office of Attorney General, is authorized to execute a settlement agreement upon the terms presented and discussed in closed session with the Legislative Council on May 08, 1992.
