## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Waiver of Indirect Cost for FY 1993 Food Distribution Program)

D E F E A T E D RES. NO. <u>92-213</u>

WHEREAS, the Tohono O'Odham Nation established a policy to require the inclusion of indirect costs in all third party funded agreements; and

WHEREAS, the policy provides for an exception and waiver of the requirement by the Legislative Council if it is in the best interest of the Nation to do so, that is when the benefits to the Nation exceeds the need to collect the revenues from the funding agency; and

WHEREAS, funding from the Department of Agriculture for the FY 1993

Food Distribution Program is insufficient to cover both direct and indirect cost needs of the program.

NOW, THEREFORE, BE IT RESOLVED that the Tohono O'Odham Legislative

Council finds that it is in the best interest of the Nation to waive

the indirect cost funding requirement for FY 1993 Food

Distribution Program.

The foregoing Resolution was presented to the Tohono O'Odham Legislative Council on the <u>2ND</u> day of <u>June</u>, <u>1992</u> at a meeting at which a quorum was present with a vote of <u>559.0</u> FOR; <u>716.0</u> AGAINST; <u>449.0</u> NOT VOTING; and <u>05</u> ABSENT, failed to pass because it did not receive a majority of the votes cast as required by Section 2 of Article V of the Constitution of the Tohono O'Odham Nation.
