

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(FY 1993 Career Center Recontract Proposal)**

3 **WHEREAS, the Tohono O'Odham Nation is presently operating the Career**  
4 **Center under FY 1992 P. L. 93-638 contract with the Bureau of**  
5 **Indian Affairs; and**

6  
7 **WHEREAS, such tribal operations have been successful and beneficial to the**  
8 **Tohono O'Odham Nation and its people; and**

9  
10 **WHEREAS, 25 CFR Part 271.20 of the Code of Federal Regulations requires**  
11 **that all proposals to recontract under P. L. 93-638 be submitted**  
12 **to the Tohono O'Odham Legislative Council for approval at least**  
13 **120 days prior to the current contract termination; and**

14  
15 **WHEREAS, the Tohono O'Odham Nation does desire to recontract for**  
16 **provision of services during FY 1993; and**

17  
18 **WHEREAS, the Tohono O'Odham Legislative Council has reviewed and**  
19 **approved the FY 1993 Career Center contract application and**  
20 **budget.**

22 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative**  
23 **Council that it does authorize and request the Bureau of Indian**  
24 **Affairs to recontract with the Tohono O'Odham Nation under**  
25 **P. L. 93-638 regulations and procedures for the provision of**  
26 **services titled: Career Center.**

3 **BE IT FURTHER RESOLVED** that the duration of this recontract shall  
4  
5 commence on October 01, 1992 through September 30, 1993.

6 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that  
7  
8 the Tohono O'Odham Nation will not fund or operate the  
9  
10 program in the interim while negotiations are still being  
11  
12 conducted and no executed contract extension has been approved  
13  
14 by the Bureau of Indian Affairs, unless the agency authorizes and  
15  
16 approves pre-award costs consistent with the Indian Self-  
17  
18 Determination Act, as amended and relevant contract regulations.

19 **BE IT FURTHER RESOLVED** by the Tohono O'Odham Legislative Council that  
20  
21 the Tohono O'Odham Nation's Officials, to wit: the Chairman,  
22  
23 Vice Chairman and any designated official are hereby authorized  
24  
25 to negotiate and execute the contract, provided however, that any  
26  
27 amendments affecting the funding or funding levels of the  
28  
29 contract shall be submitted for further prior approval by this  
30  
31 Council.

32 *The foregoing Resolution was passed by the Tohono O'Odham Legislative*  
33 *Council on the 2ND day of June, 1992 at a meeting at which a quorum was*  
34 *present with a vote of 1,724.0 FOR; -0- AGAINST; -0- NOT VOTING; and*  
35 *05 ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of*  
36 *Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the*  
37 *Tohono O'Odham Nation on January 18, 1986; and approved by the Acting*  
38 *Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,*  
39 *pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).*
